



Victim & Perpetrator Age Comparision










To address the high rates of femicide that continue to be seen within Ontario, inquest recommendations have called for collaborative intersectoral risk assessment and risk management among various systems and services. As a result of inquest recommendations pointing to system gaps in the use of these tools and collaboration, OAITH has conducted a comprehensive environmental scan and analysis to assist service providers and advocates in supporting survivors of gender-based violence.
